HOW CREDIT SCORES ARE CALCULATED	
CREDIT REPORT DATA	A score is calculated using data from a credit reporting company. Each of these companies' scores may vary slightly.
	Your credit score may vary based on when data is updated by the reporting company and when your score is being calculated.
	Reporting companies have created multiple versions of their scoring models and may update them based on FICO, VantageScore and other models.
